



I will not use the information obtained from Do Not Pay, either inadvertently or deliberately for personal gain (for example, to initiate unauthorized refunds/ payments, or to wrongfully grant/deny rights, benefits or privileges).

While assessing and researchi have a direct or indirect financi interest, I agree to report this in I may be alerted to information on persons, entities, firms or subcontractors with whom I in the event that I suspect or later become aware of a conflict of interest or financial

o the appropriate Federal agency ethics official.




Legacy Whitelist Management




