G-Invoicing – Pull Features or BizApps

Description/ Purpose	 This specification describes how to call the application programming interface (API) to extract Feature reference data (including Feature Flags) or Business Application (BizApp) reference data (including BizApp Conditions) from G-Invoicing. Features are used to control the availability of new software features Feature Flags provide the list of agencies capable of using a feature BizApps narrow the business purpose of GT&C agreements BizApp Conditions control certain attributes of a GT&C
Status Codes	Common HTTP Status Codes: • 200 – Okay • 400 – Bad request • 403 – Forbidden • 500 – Internal server error

Summary

These two REpresentational State Transfer (REST) services provide data in JavaScript Object Notation (JSON) format to an external agency partner. One resource is available to pull all Feature reference data and Feature Flags. A second service returns BizApp reference data and BizApp Conditions. Clients must have a certified Partner ID (see note below) and System ID, but there is no other authorization requirement.

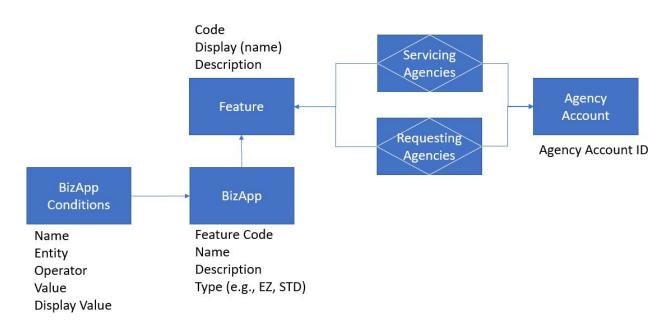
There are no Federal Intragovernmental Data Standards (FIDS) for Feature or BizApp information. JSON constraints and sample JSON may be obtained following the <u>OpenAPI | Swagger Editor</u> instructions to view <u>Feature Service 1_0</u> or <u>BizApp Service 1_0</u>. Two examples of a Feature are "Batch Order Upload" and "GTC Revert". Two examples of a BizApp are "Standard Order Processing" and "GSA Fleet Leasing (7600EZ)".

Entity Relationships

The data structures for Features and BizApps intersect. Two basic rules are that all BizApps are Features, but not every Feature is a BizApp. The connector between these two data sets is the Feature Code contained in the BizApp data, which points to a Feature. Agency readiness to use a particular BizApp on a GT&C may be viewed through the Requesting and Servicing Agency Account IDs (aka, Feature Flags) associated with the Feature. BizApp Type (e.g., STD, EZ) dictates the type of documents allowed under a GT&C.



Another important relationship is from Agency Account to the General Terms and Conditions (GT&C) agreement (not depicted above). The JSON body of a Pull GT&C response contains the Agency Account IDs for the Requesting and Servicing partners. Knowing these two IDs allows for G-Invoicing and agency systems to determine which Features are available for use under a specific GT&C agreement.

Resources

1. Get Feature Flags

This endpoint allows systems to extract all reference data describing G-Invoicing's Features, along with agency Feature Flags indicating agency availability to use each Feature as a requesting partner and (separately) as a servicing partner.

The response contains all active Features, and each feature is available to 0:M (zero-to-many) agencies, separately on the requesting side and on the servicing side. The JSON for <u>Feature Service</u> 1_0 is structured as such.

2. Get BizApps

This endpoint allows systems to extract all reference data describing G-Invoicing's Business Applications, along with BizApp Conditions which control certain attributes under a GT&C (e.g., maximum value of an EZ_10K invoice must be less than or equal to \$10,000).

The response contains all active BizApps and all active BizApp Conditions. The JSON for $\underline{\text{BizApp}}$ Service 1_0 is structured as such.
