Management Letter No. 12-02

As you may be aware, the Financial Management Service (FMS), Payment Management (PM) area is continuing the consolidation and reorganization of its operations. FMS will be closing its operations at the San Francisco Financial Center (SFC) and Check Resolution Division (CRD) in Hyattsville, MD on September 30, 2013. In this restructuring, the PM realignment of work is designed to result in two customer-focused activities with:

- Kansas City Financial Center (KFC) performing FMS Payment Processing.
- Philadelphia Financial Center (PFC) performing FMS Post-Payment Processing.

In an attempt to provide you with better visibility of upcoming changes that may affect your organization's interactions with PM, a long-term tentative schedule has been attached. To highlight the near-term, the remainder of our spring schedule is presented below in more detail.

1. May 14, 2012: Vendor/Misc. daily payment file processing will move from PFC to KFC.
(This migration will not affect any benefit specific format)
2. May 14, 2012: SPS Phone Support for payments will relocate from PFC to KFC.
3. May 29, 2012: Fedwire payments processing will transfer from PFC & SFC to KFC.
(The handling of Fedwire returns will remain at PFC)
4. June 30, 2012: Support for VA Teletrace & paper Trace Requests moves from KFC to PFC.

As payment activities (Items 1 – 3 above) transfer from PFC to KFC, two notable changes are:

- **The Payment Disbursement Officer Symbol will change from 303 to 310** on all affected payments and subsequent EFT returns.
- **All check disbursement symbols** and subsequent returns will change **from 2057 to 4030**.

FMS appreciates your patience with this consolidation and our ongoing attempts to better serve your needs and deliver quality customer service.
