

OUTLAYS BY FUNCTION

Total outlays for the United States Government in fiscal year 2022 were \$6,271.6 billion, a decrease of 8.1 percent or \$550.0 billion below the amount from fiscal year 2021. The chart below shows total outlays divided by function.

Notable changes in outlays by function are discussed briefly in the text below. The table that follows depicts the amount of outlays for fiscal years 2022 and 2021 by function, including the amount and percentage change from fiscal year 2021.

- National Defense outlays were \$766.7 billion in fiscal year 2022, an increase of 1.6 percent or \$11.9 billion above the prior fiscal year.
- Education, Training, Employment and Social Services outlays were \$676.6 billion in fiscal year 2022, an increase of 128.1 percent or \$379.9 billion above the prior fiscal year.
- Health outlays were \$914.5 billion in fiscal year 2022, an increase of 14.8 percent or \$117.7 billion above the prior fiscal year.
- Medicare outlays were \$755.1 billion in fiscal year 2022, an increase of 8.4 percent or \$58.6 billion above the prior fiscal year.
- Income Security outlays were \$865.4 billion in fiscal year 2022, a decrease of 47.5 percent or \$783.4 billion below the prior fiscal year.
- Social Security outlays were \$1,218.7 billion in fiscal year 2022, an increase of 7.4 percent or \$84.1 billion above the prior fiscal year.
- Net Interest outlays were \$475.1 billion in fiscal year 2022, an increase of 34.9 percent or \$122.9 billion above the prior fiscal year.
- Other outlays were \$599.4 billion in fiscal year 2022, a decrease of 47.5 percent or \$541.7 billion below the prior fiscal year.
