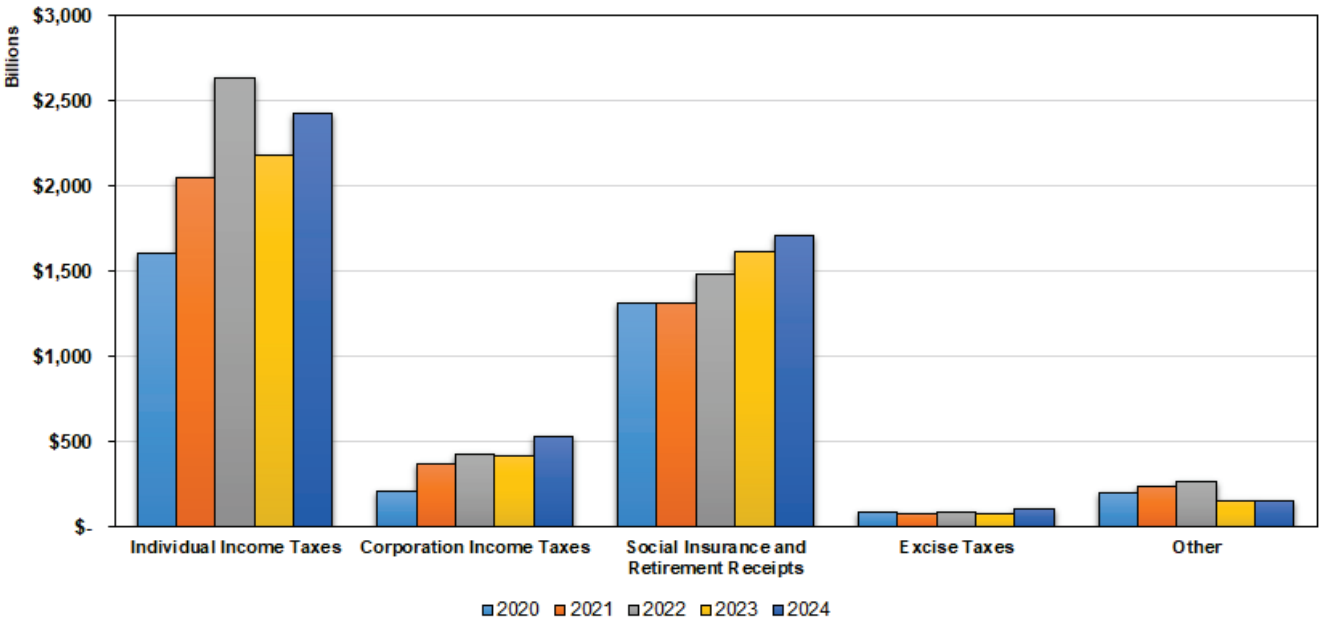
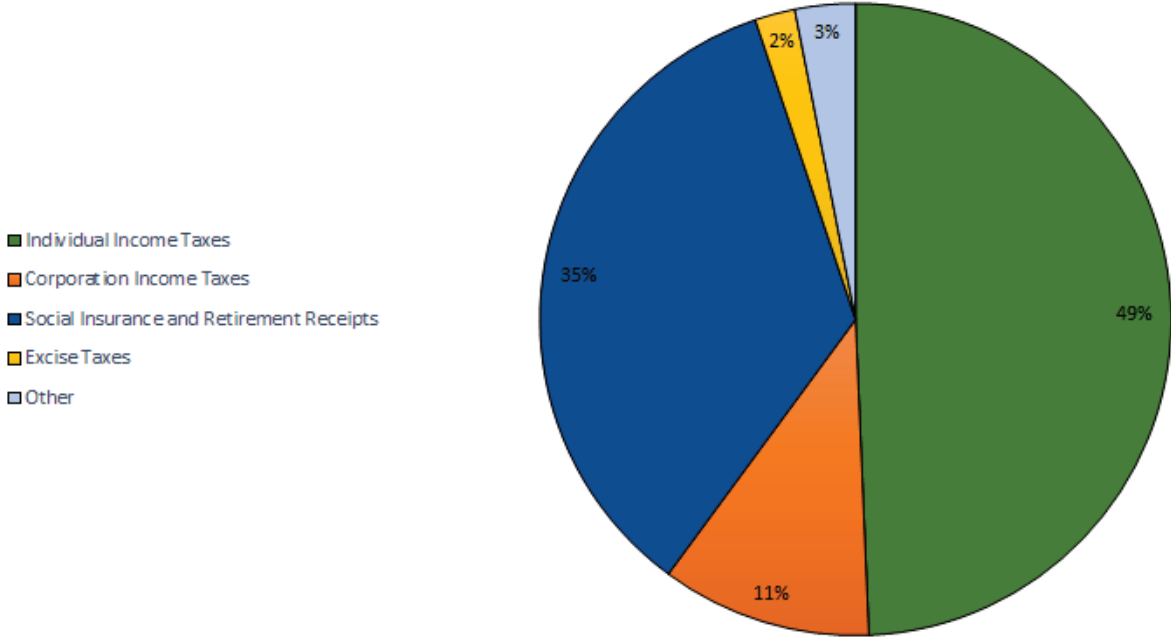


RECEIPTS BY SOURCE - SUMMARY

Total receipts for the United States Government in fiscal year 2024 were \$4,918.1 billion, an increase of 10.8 percent or \$478.8 billion above the amount from fiscal year 2023. The chart below shows total receipts divided by source.

Changes in receipts by source are discussed briefly in the text below. The table that follows depicts the amount of receipts for fiscal years 2024 and 2023 by source, including the amount and percentage of changes from fiscal year 2023.

- **Individual Income Taxes** were \$2,426.1 billion in fiscal 2024, an increase of 11.5 percent or \$249.6 billion above the prior fiscal year.
- **Corporation Income Taxes** were \$529.9 billion in fiscal 2024, an increase of 26.3 percent or \$110.3 billion above the prior fiscal year.
- **Social Insurance and Retirement Receipts** were \$1,708.9 billion in fiscal year 2024, an increase of 5.9 percent or \$94.5 billion above the prior fiscal year.
 - **Employment and General Retirement** contributions were \$1,653.0 billion in fiscal year 2024, an increase of 6.1 percent or \$94.9 billion above the prior fiscal year.
 - **Unemployment Insurance** receipts were \$48.0 billion in fiscal year 2024, a decrease of 2.9 percent or \$1.4 billion below the prior fiscal year.
 - **Other Retirement** contributions were \$8.0 billion in fiscal year 2024, an increase of 15.2 percent or \$1.1 billion above the prior fiscal year.
- **Excise Taxes** were \$101.4 billion in fiscal 2024, an increase of 33.8 percent or \$25.6 billion above the prior fiscal year.
- **Other**, including estate and gift taxes, customs duties, and miscellaneous receipts were \$151.8 billion in fiscal year 2024, a decrease of 0.8 percent or \$1.2 billion below the prior fiscal year.
 - **Estate and Gift Taxes** were \$31.6 billion in fiscal 2024, a decrease of 6.1 percent or \$2.1 billion below the prior fiscal year.
 - **Customs Duties** were \$77.0 billion in fiscal 2024, a decrease of 4.1 percent or \$3.3 billion below the prior fiscal year.
 - **Miscellaneous Receipts** were \$43.2 billion in fiscal 2024, an increase of 10.8 percent or \$4.2 billion above the prior fiscal year.
